Mr. Dougherty presented a copy of the District's Identity Guidelines and will make the specifics of the guidelines available for use in preparation of the report.

Ms. Harris discussed design elements, paper quality, mailing options and the timeframe for the project.

Ms. Harris thanked the STL Media guests for their presentation. She explained that a summary of the information presented to the Communication Committee, including additional expense for printing and postage, will be presented at the December 13.2016 Board meeting for a final review.
